The name of the legislation that all premises are complying with is the "Regulatory Reform (Fire Safety) Order 2005" Under this legislation you require the following:

Area of Compliance Required	In Place
A suitable and sufficient Fire Risk Assessment (top importance carry's a fine and penalty if not in place and will lead to compliance of all below)	
A suitable and sufficient Fire Safety Policy incorporating a fire evacuation plan and log book of maintenance of fire safety equipment and training. (free word template available on our Fire Marshal course)	
Appointed Fire Marshals (as many as your risk assessment and fire safety policy establish are required) trained every 2-3 years.	
Fire Awareness training for all staff (usually 1 hour) and Induction Fire Safety Training	
Fire Extinguisher Practical training for all staff who are required to use them e.g catering, workshop, fire marshals, dept managers etc.	
A minimum of one annual Fire Drill dependant on your Fire Risk Assessment. (typically termly for educational premises)
